In his inaugural address, President Obama said "we are a nation of Christians and Muslims, Jews and Hindus—and nonbelievers." This panel will address the relationship between nonbelievers and the First Amendment, including its speech and religion aspects. Today, arguably, that relationship has become particularly fraught because of increased government support of mild religiosity. With regard to aid, think of President Obama's proposal to continue and perhaps expand the faith-based initiatives program. And with regard to government expression, consider officials' strong endorsement of the Pledge of Allegiance, the national motto "In God We Trust," and legislative prayer. Before long, the Supreme Court will likely address the Constitutionality of these forms of governmental support for generic observance. That inquiry will draw the Justices into difficult questions concerning the Constitutional status of nonbelievers: Are nonbelievers excluded by government support of religiosity? If so, can they craft challenges based on the religion clauses of the First Amendment, which purport to protect the free exercise of "religion" alone? If they are not properly seen to be excluded, is that because non-belief should be considered a form of American faithfulness? The Court may also find itself addressing related matters, such as whether nonbelievers qualify for exemptions from general laws in the same way as traditional believers sometimes do and, finally and most generally, whether the Constitution requires or permits religion to be acknowledged and protected as a distinctive dimension of human flourishing. During the past fifteen years, the European Court of Human Rights has been engaging seriously with freedom of religion and belief rights under Article 9 of the European Convention for the Protection of Human Rights and Fundamental Freedoms. In many ways the scope and ambition of the Court's jurisprudence has been breathtaking, especially when viewed from the United States, but many questions have begun to emerge about whether the Court has established an intellectual and conceptual architecture that is up to the task of dealing with the increasingly complex cases involving religious freedom that the Court is currently facing and will soon face. This panel, comprised of experts from Europe, the United States and Australia, will address a number of important issues that have been or are in the process of being addressed by the Court, including: wearing religious symbols and clothing in public places (including the headscarf controversies and cases from France and Turkey); the rights of religious groups to register and receive recognition (including issues that arise with tiered registration systems that provide special benefits to favored religious groups); rights of religious association, such as the right of churches to hire and fire personnel on the basis of religious qualifications; free speech rights, including the line between proper and improper proselytism, hate speech, and defamation of religion. The panel will also assess the contributions the Court has made to international conceptions and theories of human rights, as well as religious perspectives (in particular, Jewish, Christian and Islamic views) on the meaning of the law and religion jurisprudence of the Court for these religious traditions.

The program focuses on routine applications of Islamic law that are central to the lives of observant Muslims but largely unaddressed in scholarly literature: practices of alternative dispute resolution (ADR). Observant Muslims regularly consult imams (religious leaders), legal scholars, and other non-state actors for Islamic legal answers and guidance in a variety of personal matters and business affairs – when getting married or divorced, writing wills, making investments, structuring commercial transactions, and more. In many instances these answers are sought and dispensed informally: in a mosque or living room, on the telephone, via email, even online. In others the exchange is more formal, as in mediation sessions or arbitration tribunals. Whatever their form, these practices constitute the most direct and immediate interactions many Muslims have with Islamic law. In this program, leading practitioners and scholars from the U.S. and Canada will explain and illustrate how these practices translate legal theory into practical answers for Muslims who seek to resolve disputes and conduct their affairs pursuant to Islamic legal rules and norms. Analogous practices in Jewish communities will also be addressed, as will ADR practices generally, providing a comparative perspective and broader context within which to assess the Islamic ADR practices.
