

### PARENTING

- Will they be allowed to teach their religion to their children without concern that the state will remove their children from the home?
- Will they be able to adopt children or provide foster care if their religious beliefs are contrary to the governing political or cultural norms of the day?
- Will they be able to make religious decisions on behalf of their children (*e.g.*, circumcision, baptism, bar mitzvah, religious education)?"
- Will they have the right to opt out of certain social or school programs that might teach their children concepts contrary to their religious beliefs?
- Will they be able to home school their children?

### EDUCATION

- Will attendance at a religious university disqualify them from graduate schools and/or becoming licensed professionals because of their religious beliefs?
- Will they become ineligible for government-funded scholarships because of their choice of religious studies?

#### EMPLOYMENT


- Will they be able to earn an honest living as health care professionals, social workers, teachers, attorneys, and civil servants without abandoning their religious beliefs?
- Will they be denied employment advancement or tenure because of their religious beliefs?

### EMPLOYMENT DISCRIMINATION

"In the days that come, circumstances will compel Christians – particularly those in certain professions – to rethink our relationship to our work. We will shown the door in some cases because of our beliefs. In others, the doors will never open in the first place – and if they do, men and women of conscience will not be able to walk through them. This is going to cost us money and prestige and perhaps vocational satisfaction." <u>The Benedict Option</u>

- Will they be allowed to hold public office if their religious beliefs do not align with political and cultural norms?

"Our Constitution was made only for a moral and religious people. It is wholly inadequate to the government of any other."




#### JOHN ADAMS

#### JAMES MADISON

"The societies in which many of us live have for more than a generation failed to foster moral discipline. In the end, it is only an internal moral compass in each individual that can effectively deal with the root causes as well as the symptons of societal decay. Societies will struggle in vain to establish the common good until sin is denounced as sin and moral discipline takes its place in the pantheon of civic virtues."




ELDER D. TODD CHRISTOFFERSON
