## The Hon Justice Nation2015, based in Christchurch

The Hon Justice Gerald Nation graduated LL.B (Hons) from the University of Canterbury, in 1974 and admitted as a barrister and solicitor in 1975. He was employed with the firm of Wynn Williams in Christchurch and became a partner in 1979. He has 35 years' experience appearing in the High Court in both criminal and civil litigation, as well as the Court of Appeal and all lower courts. Justice Nation was appointed a High Court Judge in February 2015 and is based in Christchurch.

The Hon Justice Osborne graduated with an LLB(Hons) from the University of Canterbury in 1975 and an LLM in 1980. He practised as a solicitor in Christchurch from 1976 before travelling overseas in 1980 to spend five years as a Crown Counsel, then Senior Crown Counsel, with the Hong Kong Government. He was a partner at Duncan Cotterill for 21 years and then moved to the independent bar in 2007. In the later part of his practising career he worked primarily in civil/commercial and trust litigation, and professional discipline. Justice Osborne was appointed as an Associate Judge in 2009 and was appointed as a Judge of the High Court in 2018. Justice Osborne is based in Christchurch.
