Afghanistan



Lutforahman Saeed

Visiting Scholar, International Center for Law and Religion Studies, J. Reuben Clark Law School, Brigham Young University; former Assistant Professor, Islamic Law Faculty, Kabul University

Lutforahman Saeed joined the International Center for Law and Religion Studies in 2022 as a visiting scholar. During his time at the Center, he will play a key role in upcoming projects, including Islamic perspectives on

human dignity and freedom of religion in Islam. A member of the Sharia (Islamic) Law faculty at Kabul University for more than 27 years, Professor Saeed earned his BA in Islamic studies from Kabul University in 1991 and his LLM from the University of Washington School of Law in 2010. He completed his PhD summa cum laude in the field of Islamic law and human rights at Friedrich-Alexander-Universität Erlangen-Nürnberg in December 2019, where his PhD thesis received the STAEDTLER Foundation's award for outstanding dissertation in 2020. Professor Saeed specializes in Islamic law and Islamic studies and has published in local and international journals. His book, *Islam, Custom and Human Rights: A Legal and Empirical Study of Criminal Cases in Afghanistan After the 2004 Constitution*, was published in January 2022. Professor Saeed has served as the country director of Legal Educators Support Program—Afghanistan for nearly eight years, and in 2019 he cofounded Afghanistan Legal Research and Development Organization.

Maria del Pilar Bosca Chillida earned a bachelor's degree in history from the University of El Salvador. For the past eight years, she has led the Office of Religious Affairs within the Directorate of Religious Entities and Affairs in the Government for the City of Buenos Aires. Before that, she

Ben SaundersAssociate Professor, Deakin Law School

Ben Saunders is an associate professor at Deakin Law School. He completed his PhD at the University of Queensland in 2017 on the drafting of the Australian Constitution. His research interests include constitutional law and interpretation, freedom of religion, natural law, and the intersection between Christianity and law. Professor Saunders's publications include a

critical modern edition of John Ponet's *A Short Treatise on Political Power* [1556] (Davenant Press, 2025) with Theodora J. Saunders; *Natural Law: A Guide for the Perplexed* (Lexham Press, forthcoming); *The Crisis of Civil Law: What the Bible Teaches About Law and What It Means Today* (Lexham Press, 2024); and *Responsible Government and the Australian Constitution: A Government for a Sovereign People* (Hart Publishing, 2023).

Azerbaijan



Ramin Mammadov Chairman, State Committee on Affairs with Religious Associations, Republic of Azerbaijan

Ramin Mammadov earned a bachelor's degree in international law and international relations as well as a master's degree in international relations from Baku State University. He has served in multiple government positions, including working as a specialist at the Ministry of Culture of the

Republic of Azerbaijan and deputy head of the staff of the State Committee for Work with the Diaspora of the Republic of Azerbaijan. He was later appointed deputy chairman of the State Committee for Work with Diaspora. In 2020, Mr. Mammadov was nominated as the single candidate of the New Azerbaijan Party for the parliamentary seat from the 64th Sabirabad constituency. He was elected as a member of the party's board at the Seventh Congress of the New Azerbaijan Party held on 5 March 2021. He is a member of several international organizations, including the European Union-Azerbaijan Parliamentary Cooperation Committee and the Non-Aligned Movement Parliamentary Network.



Anar Rahimov

Anar Rahimov has an extensive background in advisory roles, having previously served as an advisor at the Constitutional Court of the Republic of Azerbaijan, the Parliament of the Azerbaijan Democratic Republic, and the Parliamentary Assembly of Turkic-Speaking Countries. He currently

serves as the head of the International Cooperation Department at the State Committee on Religious Affairs of Azerbaijan. In this role, he is responsible for overseeing and managing international partnerships and cooperation related to religious affairs and contributing to the development and implementation of the country's policies in this field.



Agil Shirinov *Rector, Azerbaijan Institute of Theology*

Agil Shirinov received his PhD in social sciences—specifically in Islamic philosophical theology—from Marmara University, Türkiye. His thesis was on the existence and deity according to Nasir al-Din al-Tusi. Professor Shirinov worked as an assistant professor at the Faculty of Theology of Baku State University from 2008 to 2018. His teaching and research

interests cover the history of Islamic denominations, including radical denominations of Islam and relations between Islamic theology (kalam), medieval peripatetic philosophy, and Sufism. Professor Shirinov has authored six books and more than 20 articles on Islamic theology and philosophy as well as on the history of different Islamic denominations. He currently serves as the rector of Azerbaijan Institute of Theology.

José Luis Bazán

Legal Adviser, the Commission of Catholic Episcopal Conferences of the European Union

José Luis Bazán obtained his PhD from the University of Navarre in Spain with a thesis on the protection of private and family life in the jurisprudence of the European Court of Human Rights. While at the university, he was an assistant professor of philosophy of law and human

rights and a member of the Institute of Human Rights. He has lectured at Rey Juan Carlos University, the International University of La Rioja (Spain), and the Catholic University of Paris and has been a frequent speaker at international human rights conferences and political fora—including the European Parliament—since 2010. Dr. Bazán is a legal advisor on international

religious freedom, migration, and asylum in the Commission of Catholic Episcopal Conferences of the European Union. He is also an independent international affairs consultant working on the situation of religious minorities in Syria (proposal for its constitutional process), Iraq (measures for the protection of Christian minorities), Lebanon (provision of health and education services by churches), Nigeria (Middle Belt conflict), Mozambique (situation in Cabo Delgado), Democratic Republic of the Congo (crisis with Rwanda), and Pakistan (blasphemy legislation). Dr. Bazán is a member of the editorial committee of the *Religious Freedom in the World* report, which is published by the international charity Aid to the Church in Need, and he contributed to its 2023 report. He has published several articles and working papers in his areas of expertise.



Jelle Ludo Creemers

Director, Institute for the Study of Freedom of Religion or Belief, Evangelische Theologische Faculteit, Leuven

Jelle Ludo Creemers is a professor and the academic dean of religious studies at the Evangelische Theologische Faculteit (ETF) in Leuven, Belgium, where he also currently serves as academic dean. He is the director of the Institute for the Study of Freedom of Religion or Belief at

ETF Leuven, which conducts interdisciplinary research on the intersection of religion, human rights, and secular society with a particular focus on the European continent. Professor Creemers's primary research interest is in religion-state relations in Belgium and the implications for religious minorities, for which he received research grants from the Flemish Research Foundation in 2015 and 2021. He has written several academic and professional papers on church-state relations in the *Journal of Church and State*, *Trajecta*, and the *International Journal for Religious Freedom*. He has also coedited academic volumes on FORB-related topics in *Annua Nuntia Lovaniensia* (2019), the ICLARS Series on Law and Religion (Routledge, 2025), and the Boundaries of Religious Freedom series (Springer, forthcoming).

Jorge Emilio Dockweiler Cardenas has forged a remarkable career in the academic, political, and ecclesiastical spheres. He studied architecture and economics at the Universidad Mayor de San Andrés and holds postgraduate degrees in higher education and a master's degree in business

Pastor Jorge Miguel Rampogna serves as the director of public affairs and religious liberty as well as communication director for the Seventh-day Adventist Church in eight South American countries. He holds a degree in theology from the Universidad Adventista del Plata (UAP), and completed

postgraduate studies in corporate communication and digital influence management. He is currently pursuing a doctoral degree in pastoral theology at UAP. He leads initiatives in interreligious dialogue, freedom of conscience, and institutional diplomacy, and he coordinates communication and media strategies to strengthen the Adventist mission in the region. Cambodia



Sophanara KhanDepartment Head, Department of Religious Affairs of Cambodia

Sophanara Khan earned a master's degree in development management from Norton University in Phnom Penh, Cambodia; his studies focused on social and economic development issues at both local and international levels. In 2006 he began working at the Ministry of Cults and Religion in Phnom Penh, serving as an officer in the General Department of Religious

Affairs. In this capacity, he contributed to the administration and regulation of religious institutions across the country. Senior Legal Counsel and Director of Training, Christian Legal Fellowship

André Schutten is senior counsel and director of training and development at Christian Legal Fellowship. Called to the bar in 2011, he conducts regular analysis on the impact of government bills and court judgments. He has made arguments before the Supreme Court of Canada in five cases and arguments in five provincial courts of appeal. Mr. Schutten has been published in several law journal collections on issues including constitutional interpretation, equality and disability rights, religious and associational freedom, and freedom of expression. His writing has been published in *Canadian Diversity*, *The Supreme Court Law Review*, and the *National Journal of Constitutional Law*, and he has been cited in Canadian court judgments. He has appeared before legislative committees of the House of Commons and the Senate of Canada, and he has presented on legal issues to groups such as the Ontario Bar Association and the Runnymede Society. He also participated in the Ontario Human Rights Commission's Policy Dialogue on Human Rights, Creed, and Freedom of Religion and contributed to its resulting publication. Mr. Schutten, his wife, and four children live in Caledonia, Ontario, where he has served as an ordained elder, a part-time organist, and a former Infantry reservist.

Rocío Cortés-Rodríguez

Professor, Pontificia Universidad Católica de Chile

Rocío Cortés-Rodríguez is an assistant professor in the Department of Theology at the Pontifical Catholic University of Chile. She specializes in interreligious dialogue, focusing on the interactions between Christianity, Judaism, Islam, and Indigenous religious traditions. Throughout her academic career, Dr. Cortés-Rodríguez has explored the complex dynamics of coexistence in religiously diverse contexts. During her master's studies at the University of Helsinki (Finland), she examined the coexistence of Jews, Christians, and Muslims in 10th-century al-Andalus (present-day Andalusia). She later expanded her research during her PhD at the University of Notre Dame (USA), focusing on interreligious interactions in contemporary settings. In 2019, she introduced Chileans to scriptural reasoning methodology, an innovative method of interfaith dialogue that has fostered new opportunities for mutual understanding and collaboration among faith communities. Since 2022, Dr. Cortés-Rodríguez has served on the board of the Association for Interreligious Dialogue in Chile. This role reflects her ongoing pastoral commitment to the Department of Ecumenism and Interreligious Dialogue at the Archbishopric of Santiago.

He served in the Indian Navy for 32 years, before seeking premature retirement as Captain. He has authored/edited ten books, besides writing numerous research papers, chapters in books and articles. He participates regularly in Track II Dialogues, TV and radio talk shows and delivers talks in various civil and military institutions in India and abroad.

She has a law degree from Delhi University, a master's degree from Columbia University in New York City, and more than 30 years of experience in international business transactions and strategic advisory work. Ms. Goswami is an independent director on the boards of Maruti Suzuki India Limited and Cummins India Limited. He also earned an LLB from the University of Delhi (where he ranked second in his class) and an LLM from Harvard Law

Judge Nariman served from July 2011 to February 2013 as solicitor general of India. He also served as a member of the Bar Council of India. He was appointed to the Supreme Court of India in July 2014 and served until August 2021. He played a key role in cases such as the Triple Talaq verdict, Sabarimala temple entry, and freedom of speech matters. He founded the Supreme Court Lawyers Welfare Trust to support young lawyers.



Nazneen Rowhani Secretary General, National Spiritual Assembly of the Bahá'is of India

Naznene Rowhani is the secretary general of the National Spiritual Assembly of the Bahá'ís of India—the national governing body of the Indian Bahá'í Faith. She has served in this role for 15 years.

Indonesia



Matius Ho
Executive Director, Leimena Institute

Matius Ho is the executive director of Leimena Institute in Jakarta, Indonesia. He led the development of the Cross-Cultural Religious Literacy program that since 2021 has trained thousands of teachers in Indonesia on competencies to strengthen peaceful multifaith and multicultural societies. Under his direction, Leimena Institute has partnered and collaborated with

the Indonesian Ministry of Law and Human Rights and many leading religious and educational institutions. He has been invited to speak about the program in many countries. Mr. Ho wrote the chapter on Indonesia in *The Routledge Handbook of Religious Literacy, Pluralism, and Global Engagement* (2021). He worked in Indonesia and Singapore with Accenture, a multinational consulting firm, and served as vice secretary of Akademi Leimena Foundation, Leimena Institute's precursor, before cofounding the institute in 2005. He received his bachelor's and master's degrees from University of Wisconsin–Madison. In 2025, he was awarded an honorary doctor of divinity degree by the Henry Martyn Institute at the International Centre for Research, Interfaith Relations, and Reconciliation in Hyderabad, India.

Jacklevyn Manuputty

General Chair, Indonesia National Council of Churches

The Reverend Jacklevyn Manuputty, a graduate of Hartford Seminary's international peacemaking program as well as its master of arts program, was awarded an honorary doctor of divinity degree by the Hartford Seminary Board of Trustees. Rev. Manuputty is the cofounder of the Maluku Interfaith Institution for Humanitarian Action in Indonesia, which creates institutional capacity-building programs, develops positive public discourse, and builds a network of pluralistic conflict-prevention observers. He is actively involved in peacemaking, facilitating dialogues and promoting interfaith cooperation among many groups in the Muslimmajority country. In addition, Rev. Manuputty works on eco-justice issues, including the #SaveAru project. From 2017 to 2019, he was the assistant to the special envoy of the president for Dialogue, Interfaith Cooperation, and Civilization, and in 2019 he was elected general secretary of the Council of Churches in Indonesia, a position he still holds. Rev. Manuputty has received several awards for his interreligious peacemaking work, including the World Harmony Week Prize from King Abdullah II of Jordan in 2018; the Peacemakers in Action Award from the Tanenbaum Center for Interreligious Understanding in New York City in 2012; and the Ma'arif Award for dedication in the field of peacebuilding and interfaith relations.

Florin Seudin

Florin Seudin is a human rights activist. Since 1999 she has worked with different UN agencies as well as in the private and public sectors. She is the head of the Ethnic and Religious Components Department for the Presidency of the Kurdistan Region. Ms. Seudin worked in an advisory role

during the United Nations country assessment of Iraq's status on gender, justice, and law. She also advised on the role of women in the Kurdistan Regional Government's Economic Plan. She was awarded the Certificate of Parliament of Kurdistan as a women's rights protector in 2018, and she received the Human Rights Defender Award from Heartland Alliance International in 2018 for her contribution to the protection and promotion of human rights in Iraq. She was awarded the Minorities Rights Defender Award by the International Council for Religion and Humanitarian Dialogue for her efforts in spreading the values of love and peaceful coexistence and for promoting peaceful dialogue between different religions and civilizations of the world.

Abdullah Waise is a member of the teaching staff in the College of Islamic Sciences at Saladin University. In 2015 he completed a doctorate in comparative jurisprudence. Dr. Waise is president of the Union of Islamic Religious Scholars in the Kurdistan Region of Iraq. He has participated in many conferences abroad, including in the Republic of Türkiye, the

Hashemite Kingdom of Jordan, the Kingdom of Saudi Arabia, the United Arab Emirates, the Arab Republic of Egypt, the Republic of Algeria, Belgium, and Russia. He has written more than 10 books and has had nine papers published in scientific and academic journals. Dr. Waise is interested in issues of coexistence and the rights of religious entities as well as contemporary Islamic issues.

Matteo Corsalini

Postdoctoral Researcher, Department of Social, Political, and Cognitive Sciences, University of Siena

Matteo Corsalini is a postdoctoral researcher in the Department of Social, Political, and Cognitive Sciences at the University of Siena. His research areas include freedom of religion or belief, international human rights law, corporate law, and corporate governance. Dr. Corsalini is the author of





Francis Sylvester Kuria Kagema

Campaign to Abolish Nuclear Weapons, the 2017 Nobel Peace Prize laureate. With over two decades dedicated to interreligious peacebuilding, Dr. Kuria empowers youth and women at all levels through Kenya's Women of Faith Network and Interfaith Youth Committee. In 2008 he began serving as a consultor for the Pontifical Council for Interreligious Dialogue. Chae Young Kim
Professor, Sogang University

Chae Young Kim is a professor of religious studies at Sogang University in Seoul. He served as president of the Korean Association for Religious Studies from 2014 to 2016. Currently, he participates in a network that builds associations of young scholars of religious studies in East Asia. He also serves as an editorial board member for the international journals

Religion and the British Journal of Religious Education. Since 2016 he has directed the Won Multicultural Center and served on the boards of several NGOs, including the Nanum National Movement and the Life Movement Coalition. Through these roles, Rev. Kim continues to promote multiculturalism, social welfare, and interreligious harmony.

Natalia Alenkina
Associate Professor, American University of Central Asia

Natalia Alenkina is an associate professor at the American University of Central Asia and a licensed advocate in Kyrgyz law. She serves as a member of the Scientific Advisory Board of the Supreme Court of the Kyrgyz Republic. She is accredited by the Ministry of Justice as a legal and human rights expert. Natalia is also a member of the ICC Commission on

Arbitration and ADR and acts as the Vienna International Arbitral Centre's Ambassador in Kyrgyzstan. Ahmed Salisu Garba *Vice Chancellor, Al-Muhibbah Open University*

Father James Channan is a Pakistani Catholic priest and a member of the Dominican Order. He was ordained a priest on 9 April 1980. He has been engaged in promoting interfaith harmony—especially Christian-Muslim dialogue—for the past 40 years. He was appointed by Pope John Paul II as consultor to the Pontifical Council for Interreligious Dialogue, Vatican, and

for the Vatican Commission for Religious Relations with Muslims, where he served for 15 years. He has completed advanced studies at the Pontifical Institute for Arabic Language and Islam in Rome and at Emmanuel College, Harvard University, and American University in the United States. He is the author of four books and has participated in hundreds of national and international conferences on religious freedom and interfaith harmony. Since 2010, Father Channan has served as director of the Peace Center in Lahore. He is well-known in Pakistan and elsewhere for his efforts to promote religious freedom and build bridges of harmony, peace, and respect among all religions.



Sikander Ahmed Shah
Associate Professor of Law, Lahore University of Management Sciences

Sikander Ahmed Shah is a professor of human rights and international law at the Shaikh Ahmad Hassan School of Law (SAHSOL) at Lahore University of Management Sciences. His work focuses on religious rights, freedom of belief, and interfaith harmony. A founding member of SAHSOL, he has advised government and civil societies on constitutional

protections, minority rights, and Pakistan's international human rights obligations. He has conducted trainings for judicial officers and legal workers on minority (ethnic and religious) and gender protection, inclusivity, and rights-based service delivery. His academic work and public service reflect a strong commitment to advancing inclusive legal frameworks and fostering interfaith understanding in Pakistan.



Muhammad Zia Ul-Haq Director General, International Islamic University

Papua New Guinea Oagile Bethuel Key Dingake

Justice, Supreme Court and National Courts, Papua New Guinea

Oagile Bethuel Key Dingake is a distinguished jurist serving as a judge of the Supreme Court and the national courts of Papua New Guinea; he is the first African to hold this position. In 2013 he was appointed by the UN secretary-general to be a judge of the Residual Special Court of Sierra Leone, and in 2020 he became a justice of the Seychelles Court of Appeal. Previously, Justice Dingake served as a judge of the High Court and Industrial Court of Botswana and taught law at the University of Botswana. He has been a visiting scholar at the University of Pretoria, the University of Cape Town, and the Institute of Development Labour Law in Italy. Justice Dingake holds a PhD in law from the University of Cape Town, an LLM from the University of London, and an LLB from the University of Botswana. He also earned postgraduate certifications from the University of Oslo and the London School of Economics. An honorary professor of public law at the University of Cape Town and an adjunct professor at James Cook

University, Australia, he has authored several books on law and justice. He is a leading figure in African judicial and human rights initiatives.

Peru



Alberto Alfonso Borea Odría

Judge, Inter-American Court of Human Rights

Alberto Alfonso Borea Odría is a distinguished Peruvian constitutionalist, former legislator, diplomat, academic, and current judge of the Inter-American Court of Human Rights. He holds a law degree from the Pontifical Catholic University of Peru and pursued postgraduate studies at the University of Wisconsin–Madison and Complutense University of

Madrid. Dr. Borea's career spans public office and legal education. He served as deputy (1985–1990) and senator (1990–1992) in Peru's Congress, where he sponsored key constitutional reforms, including legislation on habeas corpus, judicial oversight, and prohibition of presidential reelection. From 2004 to 2005, he represented Peru as ambassador to the Organization of American States, chaired its committee on legal and political affairs and the permanent council, and founded the "Cátedra de las Américas." In 2006, he ran for president of Peru under the Fuerza Democrática party. He has served as a professor of constitutional law at leading Peruvian universities, including the Pontifical Catholic University, San Martín de Porres, and the University of Lima as well as at the University of San José in Costa Rica. On 27 January 2025, Dr. Borea was sworn in as a judge of the Inter-American Court of Human Rights, continuing his lifelong dedication to democratic values, human rights, and constitutionalism.



Juan Guillermo García Montúfar Sarmiento Professor of Law, Universidad de Lima

Juan Guillermo García Montúfar Sarmiento heads the real estate department at Estudio De la Flor, García Montúfar, Arata & Asociados in Lima, Peru. He has served as principal external counsel to leading real estate investment entities in Peru and also to property formalization initiatives in Peru, El Salvador, Haiti, Mexico, Egypt, and Tanzania.

Professor García Montúfar has advised the Ministry of Justice of Peru on mediation and reconciliation and has previously counseled the World Bank and the Institute for Liberty and Democracy on matters of administrative and civil law. He served as president of the commission appointed by the minister of justice to draft the Bill on Religious Freedom and to oversee its passage through Congress. Professor García Montúfar was also responsible for organizing Peru's first international symposium on religious freedom—an event organized by the Ministry of Justice with sponsorship from the International Center for Law and Religion Studies at Brigham

Young University. In addition to his legal practice, Professor García Montúfar has taught real estate law at the Universidad de Lima and Universidad San Martín de Porres.

Eduardo Muga Melgarejo

General Secretary, Ministry of Justice and Human Rights, Government of Peru

Eduardo Muga Melgarejo is an attorney. He earned his law degree from the University of Inca Garcilaso de la Vega, as well as a master's degree in public contracting from the Peruvian University of Applied Sciences (UPC), and a master's degree in civil and commercial law from Federico Villarreal National University. He currently serves as Director General of Justice and Religious Freedom at the Ministry of Justic and Human Rights in Peru. In this role, he is responsible for promoting and strengthening national and internation coordination efforts with public and private organizations at all levels related to the administration of justice, coordinating and promoting the quality of legal education and the practice of law, at the national level, and managing relations between the executive branch and religious entities. He has served in multiple advisory and legal roles across various ministries in Peru, including Advisor to the Deputy Minister of Justice, Advisor to the National Program for Action Platforms for Social Inclusion (PAIS) under the Ministry of Development and Social Inclusion, a legal consultant for the national Program "Tu Empresa" under the Ministry of Production, Head of the Legal Advisory Office for the National Infrastructure Program PRONIED, under the Ministry of Education, Head of the Legal Advisory Office for the Office of Special Projects, under the Ministry of Culture, and Special Consultant in Public Works Execution, for the Safe Water Program for Lima and Callao.

David Ángel Torres

Attorney at DTB Abogados; Area Director for Spanish-Speaking South America, J. Rueben Clark Law Society

David Ángel Torres is a Peruvian attorney with a juris doctor from the Universidad Nacional Mayor de San Marcos, where he also earned his PhD in law and political science. He holds an LLM in comparative law from Brigham Young University's J. Reuben Clark Law School, with a focus on property law, contracts, international business transactions, and constitutional law—particularly the First Amendment. He is the founding partner of DTB Abogados, a Lima-based law firm with a strong practice in civil, real estate, corporate, and arbitration law. His professional background includes international legal experience at Kirton McConkie in Salt Lake City and governmental work at the Governor's Office of Economic Opportunity in Utah. Mr. Torres has been actively involved in religious freedom research and advocacy as a founding member and past president of the J. Reuben Clark Law Society (JRLCS)—Lima Chapter. Under his leadership, the chapter organized forums on constitutional law and religious liberty in Peru, hosted interfaith panels, and published research on a blog on which Mr. Torres discussed legal

Montri Sillapamahabundit

Presiding Judge, Court of Appeal for Specialized Cases

Montri Sillapamahabundit graduated from Thammasat University with his first law degree in 1986 and was admitted to the Thai Bar Association as a permanent member a year later. He pursued further studies at Chulalongkorn University, where he earned a master's degree in business law. He entered to the Thai judiciary as a judge trainee in 1992, and after

three years of judiciary practice, he was granted a scholarship to pursue law studies abroad at in the LLM programs at American University's Washington College of Law and Cornell Law School. Judge Sillapamahabundit returned to Thailand in 1998 and was assigned to the Office of the Judiciary, where he spent four years drafting and amending laws as well as consulting and making recommendations on bills distributed to the judiciary by the Parliament and Government. He was then assigned to the Alternative Dispute Resolution Office, where he helped develop modern court-annexed mediation as well as a judicial reform program. At this time, he worked as an executive director of the Thai Arbitration Institute, a major arbitration institute in Thailand. Justice Sillapamahabundit was promoted to the upper court in the court of appeal in 2015 and rotated to several courts in Bangkok. He now works at the Court of Appeal as a presiding justice in the intellectual property and international trade section.

Jacinto dos Santos

Advisor to the Deputy Prime Minister, Ministry of Rural Development and Community Housing

Mustafa Saldirim
Assistant Professor, Istanbul Maltepe University

Mustafa Saldirim teaches undergraduate and graduate courses in the fields of civil procedure law and enforcement and bankruptcy law. From 2014 to 2024, he served as deputy secretary general of the Court of Cassation of the Republic of Türkiye; during this period, he carried out projects supported by the European Union and the United Nations and was responsible for

international relations, laws, judicial reform, and strategic planning. He worked as a public prosecutor (1995–2002), as an investigating judge responsible for the education of convicts at the General Directorate of Prisons and Detention Houses (2002–2007), and as an investigating judge at the Court of Cassation (2007–2014). Professor Vovk is a coeditor of the blog *Talk About: Law and Religion*.

Department of Arts and Law at the University of Birmingham. Professor Ahmad has been appointed chair of the steering committee of UN Environment Programme's (UNEP) Faith for Earth Initiative. She is also a member of the Interfaith Women's Council of UNEP. She is a key advisor of the Global Muslim Business Forum and a member of the UN Multi-faith Advisory Council's Interagency Task Force on Religion and Development. Professor Ahmad also sits on the steering committee of the World Bank's Moral Imperative Initiative. She is currently a board member of Faith for the Climate, Palmers Green Mosque; a member of the Women's Faith Forum UK; and an executive committee member of Barnet Multi Faith Forum. She is an international speaker, author, and thought leader who focuses particularly on faith, gender, environment, and peacebuilding. She is the global coordinator for the Alliance of NGOs and CSOs for South-South Cooperation, which works in collaboration with the UN office of South-South Cooperation. Elizabeth Rose Berridge

Senior Research Fellow, Regents Park College, University of Oxford

Baroness (Elizabeth) Berridge of the Vale of Catmose has been in the House of Lords since January 2011. On her appointment, she was the youngest female peer. Most recently she served as schools' minister (Parliamentary under-secretary of state) in the Department for Education and minister for women (February 2020–September 2021). From July 2019

to February 2020, she was the government whip for four government departments—Justice, Education, Communities and Local Government, and Work and Pensions. After reading law at Emmanuel College, Cambridge, Baroness Berridge undertook barrister's training at the Inns of Court Law School in London and practiced at Kings Chambers in Manchester, specializing in personal injury and licensing law. In 2005 she became executive director of the Conservative Christian Fellowship, a role she held until her elevation as a life peer in 2011. Having lived in Trinidad and Ghana, she pioneered relationships with Britain's ethnic minority communities for the Conservative Party. Since 2012 she has become a key voice in the deepening worldwide

discussion on freedom of religion and belief. She was a member of the steering group of the International Panel of Parliamentarians, a group whose pledge is to work together to end belief-based persecution worldwide. Baroness Berridge was the first chair of the Freedom Declared Foundation, standing down to become a trustee when she was appointed as Parliamentary undersecretary of state in February 2020. She was also the cofounder and cochair of the All-Party Group on International Freedom of Religion and Belief (2013–2019) and the director of the Commonwealth Initiative for Freedom of Religion or Belief at the University of Birmingham.

William Gibson

Emeritus Professor, Oxford Brookes University

William Gibson is an emeritus professor at Oxford Brookes University and a member of the Theology Faculty of the University of Oxford. He has held visiting fellowships at Yale University, Baylor University, and the Huntington Library. A fellow of the Society of Antiquaries of London, Professor Gibson has written widely on religion and the state between 1660 and 1900. He is the author or editor of more than 20 books on the period; his most recent publications are *Samuel Wesley and the Crisis of Tory Piety, 1685–1720* (Oxford University Press, 2021) and *Halifax: The Character of a Trimmer and Other Writings* (Oxford World's Classics, 2025). Professor Gibson is currently completing a study of James II and Wales.



James Daniel Holt

Associate Professor of Religious Education, University of Chester

James Daniel Holt is an associate professor of religious education at the University of Chester. In this role, he explores the representation and teaching of religion and worldviews in schools. He has lectured and written widely on issues of religion, Christian education, religion and popular culture, and the representation and experience of minority religions. Dr.

Holt is chair of the board of trustees for Freedom Declared Foundation, a UK-based charity advocating for freedom of religion and belief. He is chair of examiners for the General Certificate of Education (GCSE), international GCSE, and A-level religious studies with one of the major awarding organizations in England. He is the author of *Beyond the Big Six Religions: Expanding the Boundaries in the Teaching of Religion and Worldviews* (University of Chester Press, 2019), *Religious Education in the Secondary School: An Introduction to Teaching, Learning and the World Religions* (Routledge, 2015, 2022), and *Towards a Latter-day Saint Theology of Religions* (2020). He is currently writing a series of six books for Bloomsbury that introduce each of the six largest world religions: *Understanding Sikhism, Understanding Buddhism*, and *Understanding Hinduism* were published in 2023 and 2024; *Understanding Judaism* will come out in early 2026.

He served on the Labour Welfare team in Parliament before becoming an advisor on faith and civil

society to the then-leader of the opposition, Ed Miliband MP. As a partner at the Good Faith Partnership, a social consultancy helping leaders from different sectors to design creative solutions to society's more intractable problems, Dr. Rook leads the RAMP Project, a cross-party initiative seeking to transform the immigration debate in the UK. Dr. Andrew Reed is the Richard L. Evans Chair of Religious Understanding and Associate Professor of Church History. He studied Russian, Ukrainian, and European history at Arizona State University and holds Master's degrees from the University of Oxford and from the

University of Cambridge. The grant project "Building Interfaith Leaders for Future Service to the World" provides essential funding to enable the BYU Council for Interfaith Engagement to help students and faculty build greater awareness and understanding of the world's faith traditions while striving to equip students to be peacemakers and bridge builders upon graduation from BYU.



C. Shane Reese
President, Brigham Young University

C. Shane Reese began his tenure as the 14th president of Brigham Young University on 1 May 2023. Prior to his appointment, he served as BYU academic vice president from 2019 to 2023 and dean of the BYU College of Physical and Mathematical Sciences from 2017 to 2019. He also serves as a member of the Department of Statistics faculty and is an elected fellow

of the American Statistical Association. President Reese's research has centered on Bayesian hierarchical models and Bayesian optimal experimental designs. He has created statistical models addressing a range of issues, from predicting the power of solar storms to determining the safest method for destroying chemical weapons to assessing climate impact on glaciers in high mountain Asia and Antarctica. His work has also been used by the US Olympic volleyball team as well as the NFL's Philadelphia Eagles. President Reese earned a doctoral degree in

statistics from Texas A&M University and master's and bachelor's degrees in statistics from BYU.



Gene SchaerrSenior Fellow, International Center for Law and Religion Studies, Brigham Young University

Gene Schaerr specializes in civil appeals, writ proceedings, and similar matters, both in appellate courts and in the law-focused proceedings at the trial-court or agency level that often determine success or failure on appeal. He has argued and won dozens of cases in a variety of forums—including

the U.S. Supreme Court (where he has argued six cases), every federal circuit, and numerous federal district courts and state appellate courts. His win rate in the dozens of federal appeals he has argued in the past six years is over 75 percent. He was a coordinator of Sidley Austin's appellate practice from 1993 until 2005, and from 2005 until 2014 was the chair of the nationwide appellate practice at Winston & Strawn. In January 2014. Mr. Schaerr formed his own boutique litigation firm. Substantively, Mr. Schaerr's experience includes not only virtually every area of federal constitutional law, but also administrative law, antitrust, arbitration, class certification, contract law, defamation, higher education law, immigration, insurance coverage, labor and employment, patent and trademark, privacy, product liability and warranty, statutory interpretation, and tax. He has represented clients in virtually every sector and state and local government. He also teaches courses in Supreme Court litigation, religious-freedom litigation, and advanced litigation skills as an adjunct professor of law at Brigham Young University. Mr. Schaerr began law practice in 1987 following clerkships on the U.S. Supreme Court (for Chief Justice Warren Burger and Justice Antonin Scalia) and on the U.S. Court of Appeals for the D.C. Circuit (for then-Judge Kenneth Starr). He graduated in 1985 from Yale Law School, where he was Editor-in-Chief of the Yale Journal on Regulation and Senior Editor of the Yale Law Journal. From 1991 to 1993, he served in the White House as Associate Counsel to the President, where he was responsible for a wide range of constitutional and administrative-law issues, including those involving economic regulation, higher education, separation of powers, federalism, and religious freedom.



Brett G. Scharffs

Brett G. Scharffs is Rex E. Lee Chair and Professor of Law and director of the International Center for Law and Religion Studies at Brigham Young University Law School. He received a BSBA in international business and an MA in philosophy at Georgetown University and, as a Rhodes Scholar, earned a BPhil in philosophy at Oxford. He received his JD from Yale Law School, where he was senior editor of the *Yale Law Journal*. He is a recurring visiting professor at Central European University in Budapest and at the University of Adelaide Law School. For several years, he has helped organize certificate training programs in religion and the rule of law in China and in Vietnam and has taught and helped organize programs at several Indonesian universities on sharia and human rights. Author of more than 100 articles and book chapters, he has made more than 300 scholarly presentations in 30 countries. His casebook, *Law and Religion: National, International and Comparative Perspectives* (with W. Cole Durham, Jr.), has been translated into Chinese and Vietnamese, with Turkish, Burmese, and Arabic translations in process. He is coauthor with Elizabeth Clark and Amy Andrus of *Religion and Law in the USA*, a contribution to Wolters Kluwer's *International Encyclopaedia of Laws*.




Michalyn Steele

Kunihiko Terasawa Associate Professor, Wartburg College
