

FROM FREEDOM OF WORSHIP TO FREEDOM OF RELIGION AND BELIEF

Fostering the Partnership between States, the International Community and Religious Institutions

Despite being recognized as a fundamental human right in international conventions and national constitutions, freedom of religion and belief (FoRB) still suffers from a lack of a clear understanding of its ultimate contents and manifestations, as well as the risk of being reduced to mere freedom of worship.

Given that FoRB ultimately deals with the relationship between man and divinity, its definition and implementation within national and international legal systems cannot simply rely on secular sources but should rather be the outcome of a continuous dialogue between civil and religious authorities. Such dialogue would enable national legislative and judicial powers to fully appreciate the scope and role of FoRB in a person's or group's life and its evolution across time and space thus identifying and effectively tackling those situations, acts or omissions that directly or indirectly hamper the full enjoyment of this right.

Moreover, in religiously plural societies proper enactment and protection of FoRB not only serve a basic human need, but also act as fundamental prerequisites to peaceful coexistence and fruitful cooperation among religious communities, thereby fostering a public discourse and a culture conducive to acceptance and dialogue. Similarly, FoRB cannot be fully enacted and protected unless States and religious institutions join their efforts and engage, between them and with their own constituencies, in promoting mutual understanding and respect for FoRB for all citizens without distinction.

Italy's foreign policy has always paid particular attention to advancing FoRB, especially in the Mediterranean region as the cradle of the three monotheistic religions, on the belief that only through the effective implementation of FoRB can all citizens fully contribute to the development of their own societies on an equal footing and without discrimination.

This conference aims at exploring how Christianity and Islam conceive FoRB and how international and domestic laws have codified FoRB into legal principles. By analysing the differences that still exist between religious and secular visions of FoRB, the conference seeks to identify possible areas of cooperation between States and religious institutions with a view to fostering a better implementation of FoRB in existing legal systems and within civil society and social relations.
